BREEDER’S LIST & KITTEN LIST REGISTRATION

In order to protect the integrity of the Russian Blue Breeders Association we require members who use the RBBA Breeder’s List or Kitten Registrar to help with selling their kittens to sign the following undertaking:

“I undertake to abide by the GCCF’s Code of Ethics and the recommendations* of the Russian Blue Breeders Association and sell only registered kittens which are fit, healthy , at least 13 weeks of age and fully inoculated against feline infectious enteritis (FPV) and cat ‘flu (FHV and FCV). Kittens will not leave home until seven days after they have completed the full vaccination course.”**

IF REGISTRATION IS AWAITED AT THE TIME OF SALE THE TRANSFER CERTIFICATE SHOULD BE SENT TO THE BUYER AS SOON AS IT BECOMES AVAILABLE.

THIS IS A GCCF REGULATION AND FAILURE TO COMPLY MAY LEAD TO DISCIPLINARY ACTION.
